### **FULL TERMS AND CONDITIONS:**

All prices quoted are in Singapore dollars and subjected to 10% service charge and prevailing GST, unless otherwise stated.

Confirmation of holding the Event is at the discretion of the hotel and is subject to availability and other factors at time of booking.
